WASHINGTON (AP) — The Maryland high court dismissed on Friday a lawsuit that tried to block President Barack Obama from making a recess appointment to the U.S. Supreme Court. The lawsuit was filed last week by a conservative legal group challenging the legitimacy of Obama's appointment of federal appeals court judge Sonia Sotomayor to the high court. Maryland Attorney General Douglas F. Gansler, who is from the state, filed the lawsuit on behalf of Gov. Martin O'Malley, a Democrat, and the Maryland State Board of Elections. The judges said in a unanimous order that the lawsuit was not well-taken because O'Malley and the board of elections did not have standing to bring it. Gansler and the board of elections were not harmed by the actions of Obama or Sotomayor, the judges said.
